WELLNESS MEASURES

- Increased safety protocols which proved effective for maintaining good health for all persons within our facilities
- Added daily cleaning regimens with disinfectant fogging + sanitizations
- Fully implemented telehealth

ADVANCED TECHNOLOGY

- Added 20 new computers and 6 laptops
- Upgraded to a new server
- Purchased 20 Zoom accounts + cameras to support telehealth and client meetings
- Added 5 smart TVs for Zoom meetings

ONSITE RENOVATIONS

- Opened the Bud Ragalie workout room (75% complete)
- Remodeled WERC kitchen and dining room
- Added a 16 x 24 partially-covered deck

OPPORTUNITY EXPANSIONS

- Ran a daytime clinical on job search/resume development to assist unemployed clients
- Increased van ride participation from average of 4 to 17 clients for transportation for work and job searching, interviewing, etc.
- Readily provided clients with jobs from over 100 community employers

FINANCIAL WINS

- Received \$300,000 in restricted grants which helped support critical technology including:
 - PPE equipment, salaries, computer upgrades, IT equipment (telehealth, TVs, cameras, servers)
- Received a \$150,000 SBA forgiveness loan
- Received a \$400,000 grant for the WERC 40 x 40 addition (multipurpose room)

Our greatest challenge of this year was the unknown surrounding **COVID-19**. Repetitive behaviors create a safe norm and unpredictability took its toll. As reflected in the Illinois Department of Public Health's report on the 2020 epidemic:

County groups including rural, small, suburban, and urban have all experienced increased fatality rates, with increases up to 55%.

It was clear that the Serenity House team had to control the inconsistencies of the pandemic to provide as much help as possible to a hurting community.

We listened to the health experts and CDC, and acted—pivoting again and again.

The lock downs, cleaning structure, social distancing, masks, daily temperature readings, and split-shift dinners became our new routine—and quickly—a new point of structure. Zoom meetings, floor marks that acted as social distance reminders, and readily available **PPE** were all implemented to help curb the unknown as well.

Our prerogative is to be physically healthy while flourishing in mental wellness. With prioritized communication, we kept learning from our clients on how they were struggling with every new implementation. We kept our focus on honesty, *togetherness*, a brighter future—knowing the only controllable things along the way were the choices we could individually make.

Through it, we've seen that anything is possible.

Dedicated To Growth.

2020's Innovative Implementations

Serenity House added the use of **Zoom** and **telehealth** video conferencing to avoid isolation and strengthen wellness practices as much as possible.

This includes use for:

- internal groups
- client one-on-one sessions
- conversations between clients, family, and friends
- sponsor/sponsee connections
- *fulfilling court system requirements*

COVID-19 challenges... Frightening media messages... The nation's unpredictability... These all required us to focus on what was in our control more than ever.

Outstanding Efforts

The Serenity House staff are the *heroes* that got us through the emotional peaks and valleys of the 2020 pandemic. We could not get through such challenging times without them.

Counselors and administration stayed focused, informed, and malleable. Our communication was amplified by *providing* words of counsel, safety, and security at any time that struggling clients needed them.

Inspired Actions

Similar to how our clients approach sobriety, the Serenity House staff had to prioritize the valuable tool of communication to be successful. As issues arose, we talked and worked through them, then planned a safe plan of action for resolve.

Rising Above.

Unprecedented Effects

OVID-19 brought difficult challenges in 2020, most heavily impacting our outpatient services with an over 30% loss in revenue and participation in in-person meetings. This saddening reality made it clear that many were not receiving the help they needed. Regardless of Zoom and other available technologies, our clients need one-on-one, face-to-face time with our dedicated counselors. That said, we're optimistic about slowly opening back up and re-opening meetings with strong safety precautions. Having our doors open is critical in assisting those suffering from isolation, addiction, and mental health needs.

Work *shutdowns* and slow economics also impacted our clients. It became particularly difficult for clients to carry out the structure, responsibility, and commitment elements that are so critical to their recovery programs without employment. The consistency in holding a job is vital, providing physical, financial, and mental benefits that help deliver lasting sobriety.

Surrounding Morale

Some community employers were able to weather the COVID-19 storm, and kept *hiring*. Though many shifts were from 4:30am to 2pm, our dedicated clients who lost their jobs to COVID-19's effects, or who were without jobs at all, took them, pivoted, and kept *moving forward*. We utilized our community connections and transportation to help our clients stay consistent with routines and responsibilities. At times, we were taking 2 trips with our company van to a single employer to make sure our clients could stay dedicated.

Those in recovery who work with others on the same path show a greater rate of success in maintaining sobriety. March, April, and May 2020 brought the *toughest* impacts of COVID-19, yet it was then we saw the greatest togetherness of our clients. Serenity House's stringent safety measures, unity, and accountability helped us rise to the pandemic's challenges. A testament to the quality of our staff's expertise, our clients have stayed vigilant in their efforts to our program and their recovery.

Due to COVID-19, we've seen more clients in our halfway house, staying longer in our program. Many clients extended their stay in the program for over *90 days*, maintaining their sobriety and continuous commitment as they develop and refine their tools that battle addiction. We are so glad to provide an outlet for freedom. The following data reflects all it takes to do so.

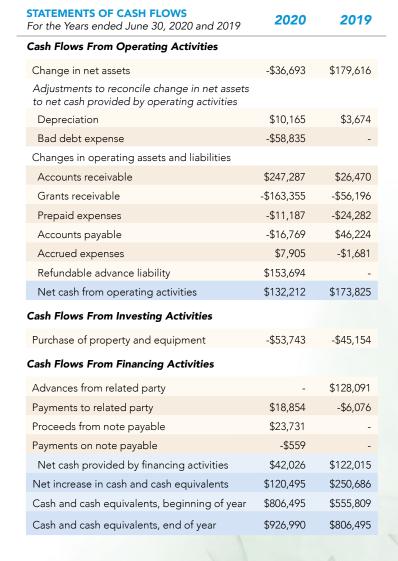

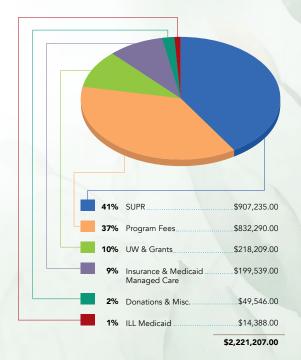

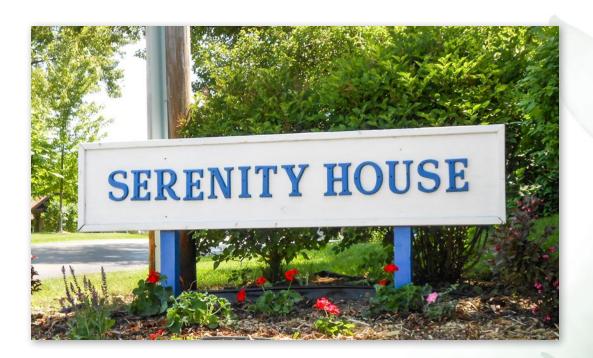
